This summer Jim Leverette as delegate and myself as alternate attended the CRC, Regional Conference, for our region, Region VII. It was conducted for the first time virtually using Zoom conference calls. Each chapter selected a delegate and alternate and our region chapters include Baton Rouge, Birmingham, Bluegrass, East Tennessee, Louisville, Memphis, Mississippi, Mobile, Nashville, New Orleans, North Alabama, Northwest Florida, Tennessee Valley and West Virginia.

Members are also welcome to attend the open business meetings but the Caucus meetings are open only to delegates and alternates.



During the business meetings each chapter gives a review of the past years including meetings, presentations, fund raising events with what worked and what did not, where each chapter stands on Research fund raising and PAOE points. The ASHRAE Presidential Award of Excellence (PAOE) is a society-wide point system to track and reward chapter achievements and awards are presented.

Each chapter can submit a Motion which if passed by the chapter delegates is submitted at our national meeting. If you have a motion that you would like to submit, want to know more about the motions or want to be considered for regional office please let our chapter president know.

Typically, at this training event, a training session is offered for each roll of a chapter such as Membership Promotion, Treasurer and YEA to list a few. This helps your chapter leadership to be able to effectively function in their assigned roll. For this CRC, virtual training sessions were held with several of our leaders attending. These leaders also need your help in the form of committees; the membership recommends at least 5 for a chapter of our size. ASHRAE also needs people to help with their committees, you can join by contacting <u>ASHRAE</u> to sit in as either a non-voting member or become a voting member. Several of our members are on numerous committees that help to develop and update our standards and manuals.

ASHRAE is a true grassroots organization. The delegates debate and vote on who they feel is best for the organization to move up through the ranks. Your opinion is needed, as every member has a voice through their delegate on the future vision of ASHRAE. As a member you can attend a CRC event, usually held in the summer time. They also have technical sessions and you get to meet other members in the different ASHRAE chapter in our region. Future locations include Biloxi, MS (Beau Rivage) in 2021, East Tennessee in 2022 and Louisville in 2023.
